You will need to bring with you **proof of all household income** for the 2017 year (including social security and retirement, pensions, interest, dividends, rental income, IRA distributions, wages, unemployment compensation, etc.), your <u>paid</u> 2017 school property tax bill and proof of age (if this is the first time you have filed for the rebate). Copies of this information will be made here at the district so you can return home with your original documents. **NOTE:** <u>You must also bring with you a copy of your completed 2017 PA1000 state property tax rebate form.</u>

<u>PLEASE NOTE:</u> We ask that you enter the driveway that is directly across from the GULF Gas Station. Please drive forward and park in the drive immediately in front of the district office building. Enter the door under the Blue Roof.

All Pleasant Valley School District Property Tax Rebates must be filed with the Business Office by June 1, 2018.

> **INSTRUCTIONS FOR 2017** SENIOR CITIZENS PROPERTY TAX REBATE

- 1. **COMPLETE PART A:** If this is your first application, provide proof of birth date and social security number. (You can use your birth certificate, PA driver's license, or PA identification card.)
- 2. COMPLETE PART B: Yes or No
- 3. **COMPLETE PART C:** Only the school taxes paid on the homestead residence in which you live are eligible for rebate. Include a copy of the property tax receipt for those paid taxes. A cancelled check is not acceptable.
- 4. WHEN TO FILE: After February 1, 2018, and before June 1, 2018.
- 5. **WHERE TO FILE:** Mail or bring your form to the district's Business Office at 2233 Route 115, Suite 100, Brodheadsville, PA 18322.
- 6. ATTACH TO THIS FORM: Attach the following documents, in order:
 - a. Signed copy of your state rebate form (PA-1000 Pennsylvania Property Tax or Rent Rebate).
 - b. Copy of your school tax receipt.
 - c. Copy of the documents supporting each income item shown on the state rebate form.
 - d. If this is your first application, copy of the proof of age.
